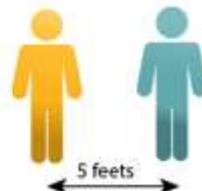

WHAT IS ALLOWED:

- **The opening of the swimming pool is authorised in accordance the conditions established in Art. 50**
 - The maximum capacity will be 75%, whenever it is possible to respect the safety distance, otherwise this capacity will be reduced in order to comply with a minimum of 5 feet of distance.
 - Disinfection of the contact surfaces at least 3 times a day...
 - An appointment will be necessary if regular use does not allow for capacity control.
- **Use of multisports courts for the practice of sport without physical contact, in accordance the conditions set out in Article 35.**
- **Playgrounds are reopened to the public, respecting preventive health and safety measures.**
- **They can be held with no more than 100 attendees and no more than 75% of the venue's capacity. There is freedom of movement throughout the territory of the Valencian community. The other communities according to their legislation.**

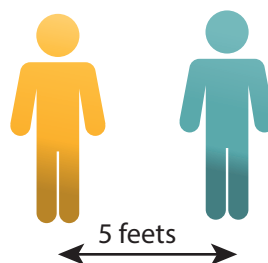
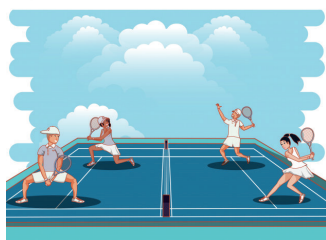
